## Tier 2.5: The Haunting of Hill House and "The Yellow Wallpaper"

## Authors and Influence

Essay Prompt (10.25.23)

The Haunting of Hill House is a masterful novel by Shirley Jackson that utilizes a female protagonist in a supposedly haunted house. Charlotte Perkins Gilman's short story "The Yellow Wallpaper," which was published a more than half a century before Jackson's novel, also follows a female protagonist's musings in what she says must be a haunted house.

In a multi-paragraph argumentative essay, examine some of the striking similarities of the two works, as well as some significant differences, in an effort to evaluate whether Jackson may have used Gilman's story as a significant influence to creating *The Haunting of Hill House*. It is absolutely critical that you go well beyond the similarities mentioned in the previous paragraph. You'll explore the similarities and differences in characters, settings, and plot events in both texts to show the extent to which you believe *The Haunting of Hill House* was or was not influenced by "The Yellow Wallpaper." Use both summary (as appropriate) and lots of concrete textual evidence/quotes from both texts to show why you believe Jackson either was or was not influenced by Gilman's story.

Your essay will include an introduction and conclusion paragraph, each of which must each contain an effective thesis, and each body paragraph must begin with an effective topic sentence. Be sure that your essay is double-spaced in a standard font (Times New Roman or Ariel) and size (11 or 12), avoids first person, and that your paragraphs are formatted correctly.

As you read, you'll keep a sort of annotated "journal" for the novel and the short story. Begin with the novel first, as it will make the project easier. The annotated journal for the novel will be broken down by chapters, and each chapter will include a few things: 1) your thoughts, questions, reactions (what you like/don't like), and connections you make (to other stories, music, movies, life) as your read, and 2) a brief 2-3 sentence plot summary at the end of each chapter of the novel. Important: For "The Yellow Wallpaper," your journal for that will include all of the above elements, but it should more importantly focus on keeping track of similarities and key differences with the novel. The journal for this short story will *not* be divided into sections; instead, treat it like a single chapter, with one 2-3 sentence plot summary at the end of the journal.

After you finish journaling, you'll complete two different pre-writing worksheets to help assist you in building your paragraphs for the essay.
